NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$.4000 per \$100 valuation has been proposed by the governing body of BOSQUE COUNTY

PROPOSED TAX RATE	\$ <u>.4000</u>	per \$100
NO-NEW-REVENUE TAX RATE	\$ <u>.3934</u>	per \$100
VOTER-APPROVAL TAX RATE	\$ <u>.4045</u>	per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for BOSQUE COUNTY from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval tax rate is the highest tax rate that BOSQUE COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that BOSQUE COUNTY is not proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 12, 2022 - 9:00 AM at 110 SOUTH MAIN STREET, MERIDIAN, TX 76665 - BOSQUE COUNTY COMMISSIONERS COURTROOM

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, BOSQUE COUNTY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the BOSQUE COUNTY of COMMISSIONERS COURT at their offices or by attending the public meeting mentioned above.
