**THIS IS A TAX INCREASE - China Spring Independent School District Proposition**

Ratifying the ad valorem tax rate of \$ .98192 in China Spring ISD for the current year, a rate that will result in an increase of 6.5% in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$2,164,622.


