COMMISSIONERS' COURT REGULAR MEETINGS FOR FY 2026**


Pursuant to Section 81.005 (Terms and Court, Meetings), Local Government Code, Vernon's Texas Codes Annotated, at the last regular term of each fiscal year the Commissioners' Court by order shall designate a day of the week on which the Court shall convene in a regular term each month during the next fiscal year.

The Bosque County Commissioners' Court terms and regular meetings shall be held at the County Seat at the Bosque County Courthouse, 110 South Main Street, Meridian, Texas 76665 in the Commissioners Courtroom. The Bosque County Commissioners' Court designates, sets and orders that regular terms during FY 2026 shall be held at 9:00 AM on Monday of each week, and that regular meetings will be held beginning on the following dates:



Additional regular meetings, if required, may be called and held in FY 2026 during the regular weekly terms. Special meetings may also be called and held in FY 2026.


