

**ORDER OF GENERAL ELECTION
CITY OF VALLEY MILLS, TEXAS**

A General Election is hereby ordered to be held on May 4, 2024 for the purpose of electing three full term Councilmembers and filling the unexpired Mayor term.

Applications for a place on the ballot will be accepted beginning January 17, 2024, and must be received no later than 5:00 p.m. on February 16, 2024.

On Election Day, the General Election shall be held at the City polling places for the precincts designated by the Bosque County Elections Administrator and approved by the Bosque County Commissioners. The polls at the designated polling places shall on said Election Day be open from 7:00 a.m. to 7:00 p.m.

The Bosque County Election Administrator is hereby appointed as the Early Voting Clerk and Custodian of Election Records. The presiding judge(s) for each of said polling places are as designed by the Election Administrator, and such presiding judge(s) are hereby authorized to appoint additional election clerks (not less than two and nor more than six) to assist in conducting said election.

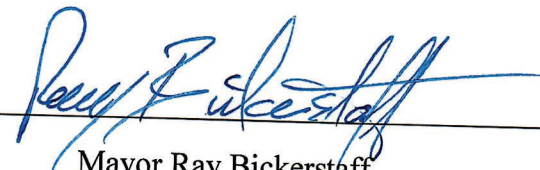
Early voting by personal appearance will be conducted at the location and times as designated in Exhibit "A" which is incorporated herein by reference and made a part hereof for all intents and purposes.

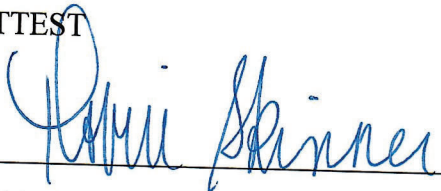
Applications for ballot by mail must be received no later than the close of business on Tuesday, April 23, 2024.
